

e. To set up and/or continue higher and/or technical institutions including teachers training institutions, medical colleges, polytechnic institutions etc., and/or any other institution regarding Health Care and hygiene, for the benefit of the general public and to apply for and obtain all permission, affiliation, recognition and or otherwise which may be necessary for setting up of the same from the relevant authorities, including government authorities;

except petty cash amount to the extent of Rs 6,000/- shall be deposited in such bank account, and all payments to be made by the trust on any account whatsoever, shall have to be paid by cheques issued in such bank account, save and except petty cash amounts to the extent of Rs 5,000/- and the petty cash sum of Rs 5,000/- shall be kept in the hands of the trustees for the time being jointly or in the hand of anyone or more of them by mutual consent. In general the trustees shall conduct the affairs of the trust jointly and in consultation with one another which shall be for the benefit of the trust and for fulfilling the purposes of the trust, and in this behalf the trustees shall be entitled to do all and every act that may be necessary;

j. It is expressly declared that no part of the trust property or its income or trust fund shall be applied for any purpose outside

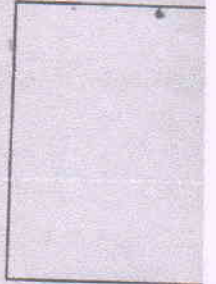
